Lake County BA 83rd Open Championships Tournament Rules

Please read carefully!

Important: USBC advises the IRS requires that we report prize winnings of \$600 or more. We must abide by this decision. If a bowler earns \$600 or more for the entire 83rd Lake County BA Championships, the member Social Security number must be provided to the Lake County BA before their check will be issued.

1. All participants must be members of Lake County BA for current season. Non-members living within the jurisdiction of the Lake County BA who are not members of another USBC local association may enter by paying an unattached membership fee of \$20.00.
2. This tournament will be conducted in strict accordance with the Constitution Rules and Regulations of the USBC and the Lake County BA.
3. Last season's final highest USBC average, including summer leagues, must be used based on 21 league games bowled. Bowler entering tournament without 2010-11 season's average must use highest current season's USBC average as of February 1, 2012, based on 18 league games bowled. Affidavit from League Secretary is required.
4. All games bowled will be given 90% handicap, based on: team average of 220 for Singles Event and All-Events, 440 for Doubles Event and 1,100 for Team Event.
5. Bowler desiring to enter tournament, who is without last season's sanctioned league average, or 18 league games bowled as of February 1, 2012 in current season, must assume 230 average.
6. Entrant having 10 pins or more higher than previous season's average, as of February 1, 2012, bowler must use their highest current USBC league average.
7. Individual entries for Singles event or Doubles event will not be accepted. One must enter both events, viz., Doubles and Singles.
8. Prize fee shall be \$14.25 per bowler per event. Bowling and expense fees shall be \$10.75 per bowler per event.
9. All prior reservations must be paid in full by January 26, 2012 6:00 PM. After that time all unpaid entry reservations will be released. NO EXCEPTIONS!
10. Any entrant that participates in Team, Doubles and Singles events will automatically be entered into the All-Events prize list. Two dollars from each entry from each event will be put in to the All Events prize fund. All Events will pay one winner out of each 12 entries in the handicap division.
11. Cash prizes in the Team, Doubles, and Singles will be awarded on handicap basis of one winner out of each 8 entries in each event.
12. Assignment of lanes will be pre-drawn by Tournament Committee.
13. Practice bowling on each starting pair of lanes only prior to Team (10) and Doubles (5) events only. Doubles will be bowled first, Singles will be bowled second.
14. Championship awards will be presented in Team, Doubles, Singles and All Events for the highest score, handicap included. Suitable awards will be presented to the actual champions (scratch) in the Team, Doubles, Singles and All Events. In case of a tie in any event, all tied participants will receive identical championship awards. In addition, all champions will receive USBC championship chevrons.
- * 15. Optional Scratch divisions fees are an additional \$5.00 per person per event. Optional Scratch divisions will pay one winner out of each ten entries in each event. No additional awards will be given to Optional Scratch division winners. Optional Scratch Team and Doubles participants must bowl together as a team on the same lane in each event. NO EXCEPTIONS! Optional Scratch division entries will be available prior to the start of each participants event. Participants wanting to participate in the Optional Scratch All Events MUST purchase entry prior to beginning of their first Team event. Individual Optional Scratch All Events total will use first Team event score regardless of when Optional Team Participates. (See rule 17 f)
16. Scores recorded by official scorekeeper or automatic scoring will be final.
17. Entrant may bowl in the five-bowler Team event as a member of more than one regularly organized team under the following rules:
 - a. Five members of any regularly organized team who are competing as bona fide members in more than one league may not bowl together on the same team more than once in this tournament.
 - b. Only three (3) members of a five-bowler team already entered in this tournament may bowl together on another five-bowler team of which they are bona fide league members.
 - c. No more than two (2) PBA members are allowed on the roster in the Team event. No more than one (1) PBA member are allowed in Doubles event.
 - d. Bowlers who are entered more than once in the five-bowler event, must be bona fide members of the league from which the team is entered and must have participated in at least 18 games of regular scheduled games of each league from which they are entered as of February 1, 2012. A player who so qualifies shall bowl on no more than one team from such league. A bowler may bowl on one additional team up to the number of certified Lake County BA leagues the bowler is participating in for the 2011-12 winter season with a minimum of 21 games by February 1, 2012.
 - e. Anyone who bowls in only one league, or enters this tournament as a substitute bowler on any five-bowler team, originating from a league in which the player has not bowled at least 18 games of the regular scheduled games, shall bowl only once in the five-bowler Team event.
 - f. When a bowler is a member of two or more five-bowler teams entered in the Lake County BA tournament, their first score bowled in the five-bowler Team event shall count toward their All Events score.
 - g. A bowler may only enter and participate in the Doubles and Singles events once.
18. Distribution of team prize money and awards shall be the team captain's responsibility.
19. Penalty for violation of any portion of above rules shall be forfeiture of all fees paid and disqualified from tournament.
20. Team captain shall be held responsible for any, and all tournament rule violations.
21. All decisions of the tournament committee are final.

POSITIVELY NO REFUNDS OF TOURNAMENT FEES PAID

All averages will be verified before any prizes are awarded.
